Government Contracts:

Private Sector Contracts:

Revenue from providing cybersecurity solutions to private companies.

Managed Security Services:

Ongoing revenue from managing cybersecurity for other organizations.

Consulting Services:

Fees from offering cybersecurity consulting and risk assessment services.

Training Programs:

Revenue from conducting cybersecurity training and certification programs.

Software Sales:

Income from selling proprietary cybersecurity software solutions.

Subscription Services:

Recurring revenue from subscription-based cybersecurity services.

Incident Response Services:

Fees for emergency incident response and recovery services.

Compliance Audits:

Penetration Testing:

Tuition Fees:

Rental Income:

Monthly rent payments from tenants.

Maintenance Services:

Revenue from maintenance and repair services offered to residents.

Property Management Fees:

Fees from managing properties owned by other investors.

Mixed-Use Development:

Income from retail and commercial spaces within residential developments.

Affordable Housing Credits:

Revenue from selling affordable housing tax credits.

Shared Ownership Programs:

Income from shared ownership and rent-to-own schemes.

Utility Billing Services:

Revenue from managing utility billing and payments for residents.

Phase 1

Infrastructure Development and Initial Services Launch

Land Acquisition and Permitting:

Initial Infrastructure Setup:
